B. Concurrent Requirements

2) Refer to Service Letter No. 002 or later approved revision.

C. Reason

- 1) Internal audits have discovered that a non-conforming condition exists on magneto serial numbers listed in Table 1.
- 2) This condition could compromise the integrity of the aircraft ignition system.
 - a) This Service Letter is issued to advise the field of this condition and require removal of the magneto assembly for inspection of the magneto housing.

D. Compliance

- IMMEDIATE: If a loss of ignition output or erratic output indication occurs during flight, land as soon as practicable. Comply in accordance with the Accomplishment Instructions 3.B – Corrective Action.
- 2) **IMMEDIATE:** For affected magnetos in service, perform a visual inspection of the magneto(s) before further flight in accordance with the Accomplishment Instructions.
- 3) **IMMEDIATE:** For affected magnetos in inventory, return within 30 days from the original issue date of this Service Letter or prior to sale or installation, whichever occurs first. Comply in accordance with the Accomplishment Instructions 3.B Corrective Action.
- 4) Compliance with the Accomplishment Instructions in this Service Letter is the terminating action for this Service Letter.

E. Approval

1) This Service Letter has been approved by Quality Aircraft Accessories.

F. Manpower

- 1) If installed, two (2.0) man hours' labor are required for the following:
 - a) Gaining access to inspect the magneto.

A. Inspection

- If effectivity of the magneto cannot be established using aircraft or engine maintenance records, before further flight, utilize the applicable aircraft maintenance manual to gain access to the Magneto assembly and inspect the serial number against the affected serial numbers found in Table 1 of this SL.
 - a) If magneto assembly serial number is affected per Table 1, before further flight comply in accordance with 3.B Corrective Action.

1) Temporary Operation Permitted:

- a) If the aircraft is in transit or not in a location where the required maintenance action can be performed, then not more than 10 flight hours of operation is permitted, to get the aircraft to an appropriate maintenance facility for compliance in accordance with Paragraph 3.B Corrective Action.
- b) If the magneto assembly serial number is not affected per Table 1, continue to 3.C. Return to Service.

B. Corrective Action

- 1) Remove the magneto assembly in accordance with the latest revision of the aircraft and/or engine manufacture's maintenance manual.

- 3) Utilizing the applicable aircraft and/or engine manufacture's maintenance manuals, install the repaired magneto assembly and proceed to 3.C. Return to Service.

C. Return to Service

1) Close all access doors and covers opened to gain access to the magneto in accordance with applicable airframe and/or engine maintenance manual.

D. Maintenance Record

1) Make an appropriate logbook entry noting compliance with this Service Letter.
